#### **Guidelines for Proposals**

- 1. The Community Service Fund application should be submitted describing the specific program/project to be funded, the need and benefit to the Long Island community and the impact it will have on the people served. An additional type-written page may accompany the application.
- 2. A detailed program/project description and budget with a specific amount requested must accompany the proposal. Our average grant award is between \$1,000 and \$2,500. Please detail your needs in escalating increments.
- 3. The applicant must submit a copy of its IRS tax-exempt status, its most recent organizational budget and financial statements, and a list of its Board of Directors.
- 4. The proposal deadline is April 15, 2024.
